This letter concerns the Suwannee River Soil and Water Conservation District Board of Supervisors desire for name change. The locally led soil and water conservation district has been in existence since 1942 and has performed outstanding services to the community, to farmers, ranchers, poultry men, dairy farmers, and landowners.

Since the regional water management district was created by the legislature in 1974 much confusion as to the two similar names.

At the Suwannee River Soil and Water Conservation Districts regular board meeting September 23, 1999 the Supervisors of the district voted to change the name from Suwannee River Soil and Water Conservation District to Suwannee County Conservation District.

Please refer to the attached copy of the September 23, 1999 minutes, page three (3), paragraph two (2) where the request is made and voted upon favorably by the Board of Supervisors in an official meeting of this board.

this amount needed the Boards approval before purchase. James motioned to approved the purchase of the digital camera and was seconded by Lee Townsend. This motion was so carried.

Senterfitt presented printout on CD interest for roll over as the CD will mature September 28th. Senterfitt presented option of one year at 5.15, two years at 5.23, three years at 5.34, and five years at 5.65 percent. Williams made motion to go for one year as interest rates appear to be on the rise. This motion was seconded by Lee Townsend and was so carried.

Senterfitt presented several options of district name change to the Supervisors. Senterfitt stated that after the district has selected a name a letter addressed to the Secretary of State with a copy of the minutes approving the name change. According to other sources the Secretary of State, upon approval, will send a letter of acknowledgment with a certificate. After being approved by the Secretary of State, copies should be sent to Supervisors of Elections and other officials doing business with the conservation district. After discussion James Williams motioned that the district name be changed from Suwannee River Soil and Water Conservation District to SUWANNEE COUNTY CONSERVATION DISTRICT. This motion was seconded by Lee Townsend, and was so carried.

Association of Past State Presidents for NRCS raffle tickets was presented to the Supervisors. James Williams motioned that the District purchase five tickets totaling \$25.00. This motion was seconded by Lee Townsend and was so carried.

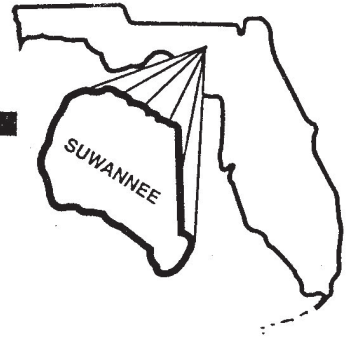
Contract for Service amendment was presented to the Board of Supervisors for their approval. After discussion Ted Henderson suggested to postpone the amendment until the County Budget is finalized. That way we would know what amounts we would be working with. James Williams motioned that the Contract for Service amendment be tabled until the next board meeting. Lee Townsend seconded the motion and was so carried.

Lee Townsend made motion to pay bills. This motion was seconded by James Williams and was so carried. Bills were presented and paid in the amount of: Contract for Service (for August and September) \$2,381.00; Alltel - \$20.95; Florida Plat - \$50.00; Reimb. to District (Digital Camera & VCR) - \$830.95; Reimb. to District (Supplies) - \$142.12; Reimb. to District (Certificate frames) - \$24.00; NFPC (Envelopes) - \$35.00; and NFPC (posters for poster & speaking contest) - \$115.00.
