

# SUWANNEE COUNTY CONSERVATION DISTRICT MEETING MINUTES

June 20, 2024

The Suwannee County Conservation District Board of Supervisors held their regularly scheduled meeting Thursday June 20, 2024 at The USDA Service Center located at 1525-B Ohio Avenue South in Live Oak. Supervisors attending were Andy Jackson, Chairman; James Williams, Secretary/Treasurer; Terry Reagan, Supervisor; and Larry Sessions, Supervisor. Also attending were Garrett McCray, SCCD Programs Administrator; Joni Sapp, SCCD Administrative Assistant; John Garrison, SCCD Conservation Technician; Aalia McClendon, NRCS District Conservationist; Shivendra Kumar, UF/IFAS Agronomic Crops RSA; and Pedro Faria (Guest).

Chairman, Andy Jackson, called the meeting to order at 7:08pm.

The Minutes of the previous meeting held May 16, 2024 were reviewed. Larry Sessions made a motion to approve the minutes, and there was a second by James Williams.

The Financial Reports were reviewed. Terry Reagan made a motion to approve those reports, and there was a second by James Williams.

Garrett McCray, SCCD Administrator, discussed our current cost-share contracts. For BMP Tools, we have \$1,664,589 obligated with (32) CSA's. RESTORE Energy has approximately \$820,000 obligated and RESTORE BMP has approximately \$418,000 obligated.

Garrett also discussed the Regional Conservation Partnership Program (RCCP) that is being submitted by the North Florida Land Trust. The Board has agreed to submit a letter of support for the collaborative effort while awaiting further details and information to determine The District's possible role in the project. Larry Sessions made a motion to approve, and there was a second by James Williams.




